Wedding Hair Service Contract

Thank you for choosing BeautyUp for your special day. Please read the contract below carefully. If there are any questions, please do not hesitate to call, text, or email me.

Bridal Trials

A bridal trial is required so that I can understand your style and overall look to serve you on your special day. The trial must be scheduled at least two (2) months prior to your wedding day. No more than three (3) styles will be tried at a single trial appointment. In the event that no trial is set, I will make reasonable efforts to accommodate your desired style.

During the trial, we will discuss the look(s) for your bridal party, if applicable. Please come prepared to narrow down bridal party looks to no more than three (3) different looks. Please note not all hairstyles fit all hair types. I advise selecting looks that will best fit the texture and length of your bridal party's individual hair, e.g. long and thick hair may not fit a classic chignon look. I will happily assist you with selecting looks that best fit you and your bridal party.

50% of the non-refundable \$200.00 deposit will be applied to your trial. The remaining balance of your trial will be due at the time of the trial appointment.

Wedding Day

On your wedding day, we will start promptly at the time set forth in this contract for applicable hair and makeup services to stay on schedule. All hair must be combed, dried, and flat-ironed to be ready for styling upon my arrival. Please schedule an appointment at least one (1) day prior to the wedding date if you would like me to straighten your hair. For natural looks, flat-ironed hair is not necessary. For all makeup services, all faces must be clean.

Section XII will dictate how many people will receive services. No changes may be made to Section XII after the time set forth in Section VII. In the event that additional bridal party members, not specified in Section XII, are seeking services, they will only be provided such services, after all individuals listed in Section XII have received services and time permits. If any services cannot be completed due to insufficient work conditions or tardiness, all fees still apply.

Stylist(s) can be scheduled to remain on location for bride and bridal party touch ups at a non-refundable rate of \$100 per hour per stylist due at time of final payment. Exact timing and location must be agreed

upon prior to the wedding day. If available, additional hours can be added on wedding day, payment due at time of service.

An appropriate workplace must be provided for myself, and if appropriate, any additional stylist(s). Ample lighting, preferable by means of natural light (such as a window) or lamps is necessary for services to be performed properly. Please have counters cleared prior to arrival in designated areas. The stylist(s) will need a low back chair and access to electrical outlets.

Travel

Travel fees are in addition to our regular service costs. There is a \$400.00 minimum for services to be provided outside of the salon.

- a. Accommodations and Airfare. For any events 100 or more miles away from Raleigh, NC, accommodations must be provided for all stylists providing services. The need for accommodations will be determined at the time of signing this contract. All costs for travel are to be paid by the client. Costs may include but are not limited to airfare, hotel accommodations (2 or 3 nights depending on destination), transportation to and from the airport in the departing and destination city, parking in the departing and destination city, per diem for meals if not all-inclusive, service incidentals, and all taxes.
- b. Mileage. The amount will be determined at time of inquiry. Travel fee is assessed for roundtrip travel. Travel fee is determined based on the current IRS Standard Mileage Rate, which is 58.5 cents per mile as of Jan. 1, 2022.
- c. Parking. Parking must be validated. In the event that parking cannot be validated, any parking or valet fees will be included in the final invoice.

Rates

Payments must be paid prior to commencement of services. Please note that wedding party prices are per person, per service. Please note that for parties receiving both hair and makeup services, a second stylist will be reserved. If any Services cannot be performed due to insufficient work conditions or tardiness by members of the wedding party , all fees will still apply.

Deposit Policy

A deposit of \$200.00 is required to reserve the wedding date. No wedding dates will be held without a signed contract and deposit. This is a **non-refundable** deposit. The \$200.00 deposit can be paid by credit card or cash. 50% of the deposit will be applied to the hair/makeup trial.

Payment

The bridal services balance will be due the day of the event. On the day of the wedding, we will accept credit cards or cash. No checks will be accepted. Please inform wedding party members and family members receiving services on the wedding day of the accepted forms of payment.

Late arrivals may not be accommodated and will not receive a refund on their services.

Cancellation Policy

Any cancellations must be made in writing at least X days prior to the date of the wedding or you will be responsible for all services agreed upon in this contract.

Inability to Perform/Force Majeure

Events outside BeautyUp's control, which are not reasonably foreseeable, shall be considered force majeure. This means that BeautyUp is released from its obligations to fulfill contractual agreements. Examples of such events are critical injury, death, fire or flood, or natural disasters. The force majeure

In the event that the contracted stylist is unable to perform the services agreed upon due to an emergency, illness, or unexpected occurrence, a trusted substitute stylist will be assigned and informed of the contracted and discussed arrangements.

Liability

All hair and makeup tools are cleaned with alcohol-based cleaning products for sanitation purposes. Any skin conditions or sensitivities should be reported by the client prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. This includes any latex allergies as most lash glues contain latex. BeautyUp is not responsible for any skin complications for allergic reactions. BeautyUp is not responsible for any damage to furnishing from cleaning products.
